

Recreational Vehicle Policy

Amended January 2026

Policy Change: **Exhibitors and Visitors** are restricted to **Golf Car use only**
ATV's and UTV's are not allowed on the grounds unless under work assignment.

Policy and Administration of **Recreational Vehicles** During Menno Pioneer
Power Show Operating Hours

*****This policy will be enforced during the 2023 Menno Pioneer Power Show and beyond**

This policy measure was requested by the members of the Menno Pioneer Heritage Association and is administered by its board of directors.

Purpose: To Limit access of recreational vehicles to the exhibit areas of the Menno Pioneer Power Show.

Also: To provide a policy that will continue use of recreational vehicles for taxi service, transporting materials and use by persons with mobility disabilities.

Definitions:

Recreational Vehicle: Any Golf Cart, Utility Terrain Vehicle (UTV), All Terrain Vehicles (ATV) and other sport utility vehicles of modern design. A golf cart is the only vehicle for use by visitors and exhibitors.

Motorized Vehicle Exhibit: Any car, truck, tractor or other motorized vehicle of an historic nature that is registered as an exhibit.

Taxi: Any recreational vehicle used for the sole purpose of transporting visitors and workers to a specific destination on the grounds.

Work Vehicle: Any recreational vehicle used for the expressed purpose of transporting materials or conducting operations in support of the Menno Pioneer Power Show.

Visitor / Exhibitor Vehicle: A golf cart used for the expressed purpose of transporting persons with mobility disabilities.

Questions?

Who is subject to the Recreational Vehicle Policy?

Any individual who operates a recreational vehicle on the Menno Pioneer Heritage Association property during operational hours (8:00 AM to 5:00 PM) of the Menno Pioneer Power Show.

Who is exempt from the Recreational Vehicle Policy?

Any individual operating a Motorized Vehicle Historic or Show Exhibit is exempt from the Recreational Vehicle Policy.

Any mobility device designed exclusively for use by a person with a disability is exempt from the Recreational Vehicle Policy.

Do I need liability insurance to operate a recreational vehicle?

A recreational vehicle **must** be supported by the owner's liability insurance policy. This is a Menno Pioneer Power Show policy that extends to all vehicles and exhibits on the grounds.

Execution of the Policy (year 2023 and beyond)

- Issue passes to eligible operators of recreational vehicles.
- Record the date, time, type of vehicle, type of pass, and name and phone # of the individual obtaining a vehicle pass.
- Sign the face of the pass and affix the pass to the vehicle
- Passes must be **displayed** on the **front** of the authorized recreational vehicle during hours of operation.

Taxi pass: Issue a taxi pass to a volunteer operating a recreational vehicle providing transportation to visitors, workers and exhibitors.

Worker pass: Issue a worker pass to a recreational vehicle in use under the definition of a worker vehicle. One pass may be granted to any one particular operation during the Menno Pioneer Power Show. Examples are tractor pull crew, threshing crew, steam engine crew, lunch stand, parade operations, corn crew, baling crew, etc. Exhibitors are not generally authorized for this pass. Additional passes may only be obtained with authorization of the MPHA board of directors.

Visitor / Exhibitor pass: Issue a visitor pass to a recreational vehicle intended for use by a person with a mobility disability. An individual requesting a visitor pass must provide proof of necessity. **GOLF CARTS ONLY, ATV's AND UTV's ARE PROHIBITED**

Proof of necessity can be:

- Any vehicle rear view mirror ADA placard issued to the individual requesting a pass.
- A photocopy of an ADA license plate, along with a photocopy of the vehicle registration and proof of identification. (cell phone photos are acceptable)
- Be a past user of a visitor pass and on the prior register kept on file by the MPHA.

Distribution:

Friday prior to the show – obtain a recreational vehicle pass at the exhibitor registration desk.

Saturday or Sunday of the show – A MPHA representative will be at the main gate to recreational vehicle passes to eligible Exhibitors / Visitors / Workers / Taxis.

The MPHA board of directors must authorize any change to this policy.
